Customer declaration on REACH, RoHS, Latex

Dear Customer,

REACH

We hereby inform you that only the following articles supplied by us contain a substance of very high concern on the SVHC candidate list (since January 2024) above 0.1 % according to Art. 33 of the REACH Regulation (Regulation (EC) No. 1907/2006):

vPvB-substance (= very persistent and very bioaccumulative):

- 2-(2-Hydroxy-5-tert-octylphenyl)benzotriazol

Plastic components including overmolded needles (cannula, stylet, mandrel) of all BIP medical devices of the following product groups:

- Biopsy Devices, disposable – only pre-mounted coaxial cannula in type HC-TX

- Biopsy Needles (upon LOT 1224)
- Fine Biopsy Needles (upon LOT 0325)
- Coaxial Cannulas (upon LOT 0325)
- Marking Clips (upon LOT 0325)
- Localization Wires (upon LOT 0325)

NOTE: A concentration of more than 0.1 % weight by weight (w/w) of this SVHC in a product does not pose a risk to humans or the environment when handled properly and has no restriction on the safe use of BIP medical devices.
